**REPORT IN BRIEF:** Bergeron Land Development, Inc approached the Town with an offer to accept storm related vegetative debris for \$10.00 per cubic yard. This agreement reflects a \$1 decrease in the fees charge at the county dump sites (\$11 per cubic yard).

RESOLUTION \_\_\_\_\_

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA AUTHORIZING THE MAYOR TO ACCEPT AND EXECUTE AN AGREEMENT WITH BERGERON LAND DEVELOPMENT, INC. FOR THE ACCEPTANCE OF STORM RELATED VEGETATIVE DEBRIS, AT BERGERON PARK OF COMMERCE, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Davie currently has a contractual agreement with Ash-Britt Environmental, Inc for collection of storm related debris; and

WHEREAS, the Town of Davie currently utilizes Broward County dump sites at a rate of \$11.00 per cubic yard for acceptance of vegetative debris; and

WHEREAS, Bergeron Land Development, Inc. has offered to accept storm related vegetative debris from the Town of Davie at a rate of \$10.00 per cubic yard which will represent a significant savings in the total costs for debris removal; and

WHEREAS, the Mayor under authority granted by the Town Council hereby accepts and executes the agreement with Bergeron Land Development, Inc. (Exhibit A) for such services.

NOW THEREFORE BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council of the Town of Davie, Florida, authorizes the Mayor to accept and execute the agreement with Bergeron Land Development, Inc. (Exhibit A) for acceptance of storm related vegetative debris at \$10 per cubic yard.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
