REPORT IN BRIEF: The Town's contract with Adams Top Notch Officials for the provision of youth sports officials for youth baseball, basketball, flag football, soccer, and roller hockey expired on February 16th 2006. The contract was in its first one year term and can be extended for two (2) additional one (1) year periods by mutual agreement of the parties. The contractor is requesting to extend the contract for the first one year renewal period with all terms and conditions remaining in effect. Staff recommends approval of this resolution.

I recommend that we extend the contract of Adam's Top Notch Officials for the coming year.


He has done a great job training and supplying officials for all the Town's youth sports programs.
