TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA APPROVING THE FLORIDA STATE CONTRACT BID AWARD FOR BLEACHERS (CONTRACT NUMBER 650-001-04-1)

REPORT IN BRIEF: The Town needs to replace bleachers which were damaged during Hurricane Wilma at two park sites: Davie Pine Island Park and Shenandoah Park. The damaged bleachers are not repairable and replacement is necessary to provide adequate spectator seating for the Town's sports programs conducted at these sites. The local municipal co-op bid the Town had utilized in the past for the purchase of bleachers expired in 2005. The co-op group did not seek a new bid for bleacher pricing based on the available use of the existing Florida State Contract for this item. The bleachers are needed for the upcoming Town football program in July. Staff recommends purchase of the bleachers from Seating Constructors USA, Inc. per attached quote based on Florida State Contract Number 650-001-04-01.






