TITLE OF AGENDA ITEM:

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ACCEPTING THE BID FOR POLICE AND FIRE DEPARTMENT UNIFORMS.

REPORT IN BRIEF:

The Town requested competitive bids on uniforms for employees of the Police and Fire Departments. The Town received two (2) bids. The recommendation is for Gold Nugget d/b/a Argo Uniform Co. who submitted the lowest bid. Gold Nugget d/b/a Argo Uniform Co. is the Town's current supplier and has provided good customer service and quality garments. With the acceptance of the bid, the initial terms of the contract will be a one (1) year agreement with an option to renew for (2) additional one year terms by mutual agreement of the parties. Extensions, if appropriate, will be sent to Town Council for approval.

RESOLUTION _____

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ACCEPTING THE BID FOR POLICE AND FIRE DEPARTMENT UNIFORMS.

WHEREAS, THE Town is in need of uniforms for employees of the Police and Fire Departments;
and

WHEREAS, the Town solicited sealed bids for such uniforms; and

WHEREAS, after review, the Town Council wishes to accept the bid of Gold Nugget d/b/a Argo Uniform Co.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council hereby accepts the bid of Gold Nugget d/b/a Argo Uniform Co. for Police and Fire Department uniforms in accordance with the prices identified in Attachment "A". Should the contractor default for any reason during the term of this agreement, the Town will award to the next lowest bidder.

SECTION 2. The initial terms of the contract, once accepted, will be one (1) year with an option to extend the contract for two (2) additional one year terms by mutual agreement of the parties. Extensions, if appropriate, will be sent to Town Council for approval.

SECTION 3. The Town Council hereby authorizes the expenditure from the Police and Fire Department Uniform Accounts.

SECTION 4. This resolution shall take effect immediately upon its passage and adoption.
