TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE COUNTY EMS GRANT PROGRAM IN PARTNERSHIP WITH OTHER MUNICIPALITIES; AND AUTHORIZING ACCEPTANCE AND EXECUTION OF THE GRANT, IF AWARDED (WITH NO MATCHING FUNDS).

REPORT IN BRIEF: The Broward County Medical Examiner and Trauma Services Division administer the EMS County Award Grants Program for projects that improve and expand EMS services in Broward County. The Davie Fire Rescue Department wishes to apply for a County grant for all twenty (20) Fire Rescue Agencies in Broward County for Roadway Safety equipment to assist personnel in being more visible on an emergency scene, thereby alerting on-coming traffic of their presence. This grant project does not require matching funds from the Town.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE COUNTY EMS GRANT PROGRAM IN PARTNERSHIP WITH OTHER MUNICIPALITIES; AND AUTHORIZING ACCEPTANCE AND EXECUTION OF THE GRANT, IF AWARDED (WITH NO MATCHING FUNDS).

WHEREAS, Broward County Medical Examiner and Trauma Services Division administers the EMS County Award Grants Program for projects that improve and expand EMS services in Broward County; and

WHEREAS; All Fire Rescue Agencies in Broward County will apply jointly for Emergency Responder Roadway Safety items; and

WHEREAS; Roadway Safety equipment will reduce the danger of fire rescue emergency responders from being injured or killed while responding to and on scene of roadway incidents.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council does hereby authorize the Davie Fire Rescue Department to partner with other municipal fire rescue departments to submit an application to the County EMS Grant Program for Emergency Responder Roadway Safety Grant.

SECTION 2. The Town Council authorizes the Mayor to accept and execute all necessary grant applications, contracts and documents for the project and the Fire Chief and/or designee to implement the grant, if awarded.

SECTION 3. This Resolution shall take effect immediately upon its passage and adoption.
