**TITLE OF AGENDA ITEM:** A RESOLUTION OF THE TOWN OF DAVIE ACCEPTING THE BID FOR AN INCLUSIVE PLAYGROUND (BID #06-20).

**REPORT IN BRIEF:** The Town of Davie conducted a formal bid for the construction of an Inclusive Playground at Davie Pine Island Park to include: Playground Equipment, Surfacing and a Shade System. Eleven bid responses were received. The low bid response received was \$153,400. This submission was rejected because it did not meet all of the bid specification requirements. The second lowest bid received was \$158,241.47. This bid, submitted by Playscapes Enterprises, meets all specification requirements and is recommended for bid award. The playground project is designed to be barrier free and to provide a developmentally advantageous, fully integrated and socially inviting play area for children of all abilities including children with disabilities. The Town has received a grant award in the amount of \$75,000 from the Children Services Council of Broward County for this project. The estimated cost for the project was \$150,000.00 as budgeted in the Towns Five Year Capital Plan. Additional funding in the amount of \$8241.47 is needed for this project. Staff recommends bid award as referenced in the resolution.
