TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, EXTENDING THE AIRPORT/TRANSPORTATION ADVISORY BOARD FOR ONE YEAR.

REPORT IN BRIEF: On December 18, 2002, the Town Council created the Airport Advisory Board to consider the effects of the Hollywood/Fort Lauderdale Airport expansion on the environment due to air pollution and noise pollution caused by air traffic flowing over the Town and to provide appropriate advice to the Town Council. The Board was created for a one-year period; however, Council has continued to extend their term for one year, and the current term is set to expire in December 2006. Staff is recommending that the Board's term be extended for an additional year.

PREVIOUS ACTIONS: Council approved resolutions R-2003-329 on December 18, 2002, R-2003-307 on December 3, 2003, R-2004-275 on December 15, 2004, and R-2006-001 on January 4, 2006.

RESOLUTION NO. _____

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, EXTENDING THE AIRPORT/TRANSPORTATION ADVISORY BOARD FOR ONE YEAR.

WHEREAS, on December 18, 2002, the Town Council of the Town of Davie created the Airport Advisory Board for one year; and

WHEREAS, in subsequent years the Town Council has extended the Board's term for one year; and

WHEREAS, the Town Council has moved to expand this Board to include the concept of transportation issues collectively thereby renaming it the Airport/Transportation Advisory Board; and

WHEREAS, those issues may include major thoroughfares which impact the Town such as I-595, I-75 and the Florida Turnpike; and

WHEREAS, the Airport Advisory Board was established to consider the effects of the Hollywood/Fort Lauderdale Airport expansion on the environment due to air pollution and noise pollution caused by air traffic flowing over the Town and provide appropriate advice to the Town Council; and

WHEREAS, the Town of Davie will be impacted by the current and future increase in air traffic; and

WHEREAS, there are programs available to mitigate or abate noise and that the Airport/Transportation Advisory Board should seek out information to provide recommendations to the Town Council to lessen the impact; and

WHEREAS, the proposed expansion issue has yet to be determined and staff recommends that the Airport Advisory Board's term be extended for one year.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. That the Airport/Transportation Advisory Board's term be extended for one year.

SECTION 2. That the Airport/Transportation Advisory Board is hereby directed to provide information regarding programs to mitigate or abate noise caused by the airport.

SECTION 3. That the Airport/Transportation Advisory Board is to provide information on a broader scope encompassing transportation collectively and consider such issues as sound walls, Light-Rail systems, and any changes or improvements of major transportation corridors which effect the Town.

SECTION 4. That this resolution shall take effect immediately upon its passage and approval.
