**TITLE OF AGENDA ITEM:** A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE APPROPRIATE TOWN OFFICIALS TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE STATE OF FLORIDA DEPARTMENT OF HEALTH TO STORE CHEMICAL ANTIDOTE KITS KNOWN AS CHEMPACKS AND AUTHORIZING THE APPROPRIATE TOWN OFFICIALS TO ACKNOWLEDGE SUCH APPROVAL BY AFFIXING THEIR SIGNATURES TO SUCH DOCUMENT.

**REPORT IN BRIEF:** This Memorandum of Agreement (MOA) is entered by and between the State of Florida Department of Health, and the Town of Davie Fire Rescue Department, for the purpose of effectively responding to acts of chemical terrorism and other chemical emergencies posing a public health crisis. The Centers for Disease Control and Prevention (CDC) agrees to pre-position sustainable repositories of antidotes (“CHEMPACKS”) in locations in Florida. This MOA establishes the terms, conditions, and responsibilities between the parties for deployment, management, and maintenance of this federally owned asset. This MOA is subject to the provisions of all applicable Federal and State laws, regulations, policies and standards. The Town is one of several municipal governments participating in this program throughout the State which collectively benefits all residents and visitors..

WHEREAS, The State of Florida Department of Health and the Center for Disease Control agrees to pre-position chemical antidotes known as CHEMPACK; and

WHEREAS, the Town agrees to provide storage for the CHEMPACK antidote kits; and

WHEREAS, the Town desires to authorize the execution of the Memorandum of Agreement with the State of Florida Department of Health; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council of the Town of Davie authorizes the appropriate Town Officials to execute the agreement with the State of Florida Department of Health. A copy of the agreement is attached.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.
