TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AWARDED THE BID FOR TWO (2) TRAILER MOUNTED 30 KW GENERATORS TO NEFF RENTAL, INC.

REPORT IN BRIEF: A competitive bid was conducted for the purchase of two (2) 30 KW Trailer Mounted Generators. The Town sent out bid specifications to twenty-seven (27) prospective bidders. The Town received twelve (12) responses. The recommendation is for Neff Rental, Inc. who was the lowest bidder for a total price of \$31,592 (\$15,796 per generator).




