

RESOLUTION NO.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ESTABLISHING AN ANNUAL FIRE SAFETY INSPECTION FEE SCHEDULE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Florida law provides that municipalities are authorized to charge fees to defer the costs of the services rendered by the municipality; and

WHEREAS, annual fire safety inspections are an integral part of a comprehensive safety program to ensure that certain fire safety features are installed and maintained in the buildings of this community; and

WHEREAS, the South Florida Building Code requires annual fire inspections within this community; and

WHEREAS, the benefit derived from the fire safety inspections is passed directly to the entities whose structures are being inspected; and

WHEREAS, the fire safety inspections fees for annual inspections shall be utilized to offset the costs of administering the inspection and review process; and

WHEREAS, the burden of fire safety inspection fees would be borne by those directly benefiting from the inspection and review; and

WHEREAS, the Town Council deems it to be in the best interest of the citizens of the Town of Davie to provide for a schedule of fees for annual fire safety inspections; and

WHEREAS, the Town Council, having legally advertised its intent to set fees for these services and having presented opportunity for discussion and deliberation of these fees, wishes to establish the fee schedule for these services.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The schedule for Annual Fire Safety Inspection fees, a copy of which is attached hereto as Exhibit "A", is hereby established by the Town of Davie.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.

## ANNUAL FIRE SAFETY INSPECTION FEE SCHEDULE

### **Commercial, industrial and public assembly buildings:**

Minimum fee first five thousand (5,000) square feet	\$60.00
Each additional one thousand (1,000) square feet	\$ 1.50
Reinspection(s)	\$30.00

### **Multi-Family:**

Three (3) to ten (10) units	\$40.00
Each additional unit	\$ 1.50
Reinspection(s)	\$20.00

### **Hotel, motels, and time-shares:**

Minimum fee	\$60.00
Fee per room	\$ 3.40
Reinspection(s)	\$30.00

### **Collection of fees:**

All annual fire safety inspection fees shall be billed at the time of inspection and shall be delinquent if not paid within thirty (30) days of the billing. Anyone who fails to pay the necessary required inspection fees when due shall pay an additional ten percent (10%) of the required inspection fee.
