SUBJECT: Proposed Resolution - Purchase Police Vehicle Equipment

The Police Department is in need of safety equipment for Police vehicles. Law Enforcement Supply Company, Inc. will furnish emergency lighting equipment for Police vehicles, piggybacking the State of Florida Contract #070-001-99-1, in the amount of \$10,189.87. The three rear transport seats and three protective transport screens for Police vehicles, in the amount of \$1656.60, can be purchased from Law Enforcement Supply Company, Inc., piggybacking Broward County Co-op Bid #97-C-013F. The Law Enforcement Trust Funds are to be utilized for this expenditure.

RESOLUTION _____

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE PURCHASE OF POLICE VEHICLE EQUIPMENT PIGGYBACKING THE STATE OF FLORIDA CONTRACT AND ALSO THE BROWARD COUNTY CO-OP BID UTILIZING LAW ENFORCEMENT TRUST FUNDS.

WHEREAS, the Davie Police Department is in need of equipment for police vehicles; and

WHEREAS, Law Enforcement Supply Co. Inc., will supply emergency lighting equipment to the Town for the purpose of safety lighting for the Police Department vehicles in the amount of \$10,189.87, piggybacking the State of Florida Contract # 070-001-99-1; and

WHEREAS, the Law Enforcement Supply Company, Inc., will provide rear transport seats at \$274.00 each for 3 seats at a total of \$822.00 and setina protective transport screens at \$278.20 each for 3 vehicles at a total of \$834.60, piggybacking the Broward County Co-op Bid #97-C-013F; and

WHEREAS, the Police Department wishes to utilize funds from the Law Enforcement Trust Funds to purchase this vehicle equipment, in compliance with Florida State Statute 932.704, which is not a recurring cost.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby accepts State of Florida Contract # 070-110-98-1 for the purchase of emergency lighting equipment.

SECTION 2. The Town Council of the Town of Davie hereby accepts Broward County Co-op Bid #97-C-013F, for the purchase of equipment for rear transport seats and protective screens.

SECTION 3. The Town Council authorizes this total expenditure from the Law Enforcement Trust Fund.

SECTION 4. This resolution shall take effect immediately upon its passage and adoption.
