**SUBJECT:** Proposed Resolution - Troops to COPS 99 Grant Application

The Troops to COPS 99 grant program is being offered to law enforcement agencies that hire recently separated military veterans as Police Officers. This grant is designed to complement the Universal Hiring Program with additional funding totaling \$40,425.32, for the four eligible veterans hired. This is a reimbursement grant, and there is no local match grant requirement for the Troops to COPS 99 Program, nor is there a retention requirement.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR AND APPROPRIATE STAFF TO SUBMIT AN APPLICATION FOR GRANT FUNDING FOR TROOPS TO COPS 99 PROGRAM UNDER THE U.S. DEPARTMENT OF JUSTICE.

WHEREAS, Troops to COPS 99 funding is available to Law Enforcement Agencies to hire recently separated military veterans to serve as law enforcement officers; and

WHEREAS, the Troops to COPS 99 grant is designed to complement the COPS Universal Hiring Program with additional funds of \$40,425.32 for related hiring expenses; and

WHEREAS, there is no local cost share or match requirement by the Troops to COPS 99; and

WHEREAS, it is in the best interest of the Town of Davie that the Davie Police Department apply for and secure grant funding under the Troops to COPS 99 grant program.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby authorizes the Mayor, Town Administrator and/or appropriate staff to submit an application for grant funding under the Troops to COPS 99 grant program.

SECTION 2. The Town Council hereby authorizes the acceptance of the grant if awarded.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
