The COPS MORE 98 Grant #1999-CM-WX-2140 has been awarded to the Town of Davie for the purchase of technology and equipment in the total project amount of \$574,800. In Resolution R-98-211, Town Council approved submission of the application and approval when the grant was awarded. We are now requesting to purchase the laptop computers and related hardware through Comark Grant and Educational Sales on state bid, and related software through HTE, a sole source provider, in an amount not to exceed the grant project total of \$574,800. We are also requesting that the approved local grant match of \$143,700 be expended from the Law Enforcement Trust Fund.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE PURCHASE OF LAPTOP COMPUTER AND RELATED HARDWARE AND SOFTWARE, PER RESOLUTION R-98-21, APPROVING THE APPLICATION AND AWARD OF THE COPS MORE 98 GRANT FOR TECHNOLOGY AND EQUIPMENT.

WHEREAS, Resolution R-98-211 approved the submission of the grant application and acceptance of the grant award for technology and equipment under the COPS MORE 98 Program administered by the U. S. Department of Justice; and

WHEREAS, this grant funding will enable the Police Department to complete the laptop computer program; and

WHEREAS, the Police Department wishes to purchase the laptop computers and related hardware through Comark Grant and Educational Sales on state bid 250-040-99-1, and related software through HTE, a sole source provider, in an amount not to exceed the grant project total of \$574,800; and

WHEREAS, the Davie Police Department desires to fund the local required grant match, in the amount of \$143,700, to be funded from the Law Enforcement Trust Fund, in accordance with Florida Statutes 932.704, which is not a recurring cost.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby authorizes the purchase of laptop computers and related hardware from Comark Grant and Educational Sales through state bid 250-040-99-1, and related software from HTE, a sole source provider in the amount not to exceed the project total of \$574,800.

SECTION 2. The Town Council hereby approves the expenditure of \$143,700 from the Law Enforcement Trust Fund for the required local match.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
