SUBJECT: Resolution

TITLE OF AGENDA ITEM:

A resolution of the Town of Davie, Florida, authorizing the Town of Davie to approve a contract with Dina P. Ayers for preschool.

REPORT IN BRIEF:

The Town provides recreational preschool classes at the various facilities in the Town of Davie. Instructional recreation programs such as preschool classes benefit the participants and the Town of Davie. The contract allows the Instructor to be paid seventy five (75) percent of the fee that is collected from the participant. The Town receives twenty five (25) percent of the fee, which compensates the Town for use of the facilities, overhead and advertising costs for the class. The Instructor collects the entire fee (the checks are made out to the Town) and submits them along with a roster to the Town, after the registration period. The Town then pays the Instructor, on a regular cycle, once the class has started. The preschool instructor has taught for the Town many years and I foresee no problem with this class. The expected payment to the Instructor of \$50,000 requires the contract be approved and signed by the Town Council. The Instructor is providing the certificate of insurance with the Town included as "additional insured".

PREVIOUS ACTIONS:

Resolution 88-273 authorizing the Community Services Director to approve contracts for part-time contractual personnel utilized in the various recreational activities. This is a renewal of the contract previously approved by resolution R98-271.

RESOLUTION _____

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE TOWN OF DAVIE TO APPROVE A CONTRACT WITH DINA P. AYERS FOR PRE-SCHOOL

WHEREAS, the Town is desirous of sponsoring cultural and recreational events for the benefit of the public; and

WHEREAS, the instructor's fee is based upon the number of students that register and pay for the class; and

WHEREAS, due to the increased availability of locations on a Town-wide basis and the popularity and quality of instruction, the instructor will be compensated 75% of the class fee, not to exceed \$50,000.00; and

WHEREAS, after review, the Town Council wishes to authorize the Mayor to approve contracts with Dina P. Ayers for pre-school.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby approves a contract and authorizes the appropriate Town official to enter into a contract attached as Exhibit "A" with Dina P. Ayers for pre-school at Ivanhoe Community Room throughout the fiscal year 1999/2000.

SECTION 2. This resolution shall take effect immediately upon its passage and adoption.

**TOWN OF DAVIE
RECREATIONAL ENHANCEMENT INSTRUCTOR'S CONTRACT**

INSTRUCTOR'S NAME:	Dina M. Ayers
CLASS TITLE:	Pre-School
CLASS FEE:	Monday, Wednesday, Friday \$120.00 a month; Tuesday and Thursday \$100.00 a month
NUMBER OF WEEKS:	One month sessions, Continuous
NUMBER OF PARTICIPANTS IN CLASS:	Monday, Wednesday, Friday - maximum 25; Tuesday and Thursday - maximum 15
INSTRUCTOR'S FEE:	75% Instructor, 25% Town
CLASS BEGINS THE DAY OF:	October 1, 1999
CLASS ENDS DAY OF:	September 30, 2000
CLASS MEETS AT:	Ivanhoe Community Center 9:00 am - noon

The Town of Davie and Dina M. Ayers, hereafter known as the instructor, enter into this agreement on August 30, 1999, whereby the Town of Davie will receive the registration money and forms, and the instructor will receive the amount stated above which shall be 75% of the registration fee with 25% of the registration fee and all non-resident fees retained by the Town of Davie.

The instructor will provide all class materials and equipment needed or pertaining to the above stated class. The instructor also acknowledges responsibility in handling any and all income taxes derived from the instructor's fees. (The instructor is actually self-employed and is contracting the class from the Town of Davie.) Insurance such as personal health care or workmen's compensation is not provided by the Town of Davie. No payment will be given for holidays or unscheduled overtime. The instructor will notify students if he/she cannot teach class any day and reschedule missed session. Instructors will be paid as agreed with the Town.

The instructor is to provide the Town of Davie a certificate of insurance for one million dollars (\$1,000,000.00) with the Town of Davie included as additional insured. The certificate must be valid the entire length of the contract.

Instructor agrees to support the Town of Davie **Scholarship Program**. The scholarship program offers an opportunity for students who cannot afford to pay for classes the chance to participate. For every ten paid students registered, the instructor agrees to permit the Town of Davie to place one qualified scholarship student into this class at no cost.

Any violation of the above agreement will be reason for immediate termination of this contract.
