SUBJECT: Resolution

TITLE OF AGENDA ITEM: A Resolution of the Town of Davie, Florida authorizing the Mayor, Town Administrator and appropriate staff to accept supplemental funding under the "COPS MORE" Program administered by the Department of Justice Office of Community Oriented Policing Services.

REPORT IN BRIEF: The funding which has been made available is a renewal of the COPS MORE Grant CMWX0229, and there is no requirement to submit an application to extend this second year of supplemental funding. This resolution is to request acceptance of this renewal grant for second funding. The renewal of the COPS MORE Grant Program provides funding in the amount of \$233,475.00, to offset the salaries for the ten previously hired civilian personnel. The local cost share is \$77,825.00 for a period of one year, which is 25% of the total project cost of \$311,300.00.

PREVIOUS ACTIONS: Resolution R-96-340 approved the original application and acceptance for funding to hire civilian personnel.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR AND APPROPRIATE STAFF TO ACCEPT SUPPLEMENTAL FUNDING UNDER THE "COPS MORE" PROGRAM ADMINISTERED BY THE DEPARTMENT OF JUSTICE OFFICE OF COMMUNITY ORIENTED POLICING SERVICES.

WHEREAS, Resolution R-96-340 approved the application submission, and acceptance of, Grant #97CMWX0229, awarded to the Town of Davie; and

WHEREAS, additional funding has been made available under the COPS MORE Program; and

WHEREAS, this is the second year of the grant of which 10 Police Service Aides were hired in the first year and this funding will supplement the salaries of these civilian personnel; and

WHEREAS, the funding awarded to the Town is \$233,475.00 with a local cost share requirement of the COPS MORE Program of \$77,825.00 which is 25% of the amount funded of \$311,300.00; and

WHEREAS, it is in the best interest of the Town of Davie Police Department to accept the supplemental funding under the COPS MORE Program, with the matching funds to be expended from the General Fund.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby authorizes the Mayor, Town Administrator and/or appropriate staff to accept this additional funding of Grant #97CMWX0229

SECTION 2. The Town Council hereby authorizes the Mayor to accept the grant and authorizes appropriation of the local share of \$77,825.00 from the Town's General Fund, Police Department salary accounts.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.





RESOLUTION NO. R-96-340

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR AND APPROPRIATE STAFF TO SUBMIT AN APPLICATION FOR FUNDING UNDER THE "COPS MORE" PROGRAM ADMINISTERED BY THE U.S. DEPARTMENT OF JUSTICE OFFICE OF COMMUNITY ORIENTED POLICING SERVICES.

WHEREAS, the U.S. Department of Justice's Office of Community Oriented Policing Services administers the COPS MORE: Making Officer Redeployment Effective Program; and

WHEREAS, funding is available under COPS MORE Program provides for technology, equipment and civilian employees; and

WHEREAS, the COPS MORE funding is contingent upon the local government's demonstration that the grant requested will result in an enhancement of community oriented policing efforts within that jurisdiction; and

WHEREAS, the Town of Davie has determined that utilizing civilian employees will enhance that police officer's ability to respond to law enforcement issues in support of the Police Department's community policing orientation; and

WHEREAS, the local cost share requirement of the COPS MORE Program is a minimum of 25% of the amount funded; and

WHEREAS, it is in the best interest of the Town of Davie that the Police Department apply for and secure funding under the COPS MORE Program.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. That the Town Council authorizes the Mayor, Town Administrator and/or appropriate staff to submit an application for funding under the COPS Making Officer Redeployment Effective (MORE) Program.

SECTION 2. The Town Council hereby authorizes the Mayor to accept the grant if awarded and authorizes the appropriation of the local share.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.




