SUBJECT: Resolution

TITLE OF AGENDA ITEM: A resolution of the Town of Davie, Florida, authorizing the expenditure of \$5,250.00 from the Law Enforcement Trust Fund towards the purchase of a new canine for the Davie Police Department.

REPORT IN BRIEF: Departmental promotions provides us with a K-9 Officer, who will require a new dog for the K-9 Unit. The dog previously used in the K-9 Unit was privately owned by the officer assigned to the unit. When he was promoted out of the K-9 Unit he took the canine with him. Informal bids have been solicited with Orchard Knoll Kennels, Inc., submitting the lowest bid of \$5,000.00 plus shipping of \$250.00. The \$5,250.00 purchase will be funded from the Law Enforcement Trust Fund.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE EXPENDITURE OF \$5,250.00 FROM THE LAW ENFORCEMENT TRUST FUND TOWARDS THE PURCHASE OF A NEW CANINE FOR THE DAVIE POLICE DEPARTMENT

WHEREAS, the Davie Police Department is in need of a dog for the K-9 Unit; and

WHEREAS, the Davie Police Department has solicited informal bids to purchase a Belgian Malinois for the Police Department's K-9 Unit; and

WHEREAS, Orchard Knoll Kennels, Inc., in Angier, North Carolina, will furnish a Belgian Malinois for \$5,000.00, plus \$250.00 shipping; and

WHEREAS, the Davie Police Department wishes to accept the bid and expend \$5,250.00 for the purchasing and shipping of a new canine from Orchard Knoll Kennels, Inc., with funding to be from the Law Enforcement Trust Fund, in accordance with Florida State Statute 932.704, which is not a recurring cost.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. That the Town Council of the Town of Davie hereby accepts the bid to purchase the canine in the amount of \$5,000.00, plus shipping of \$250.00, from Orchard Knoll Kennels, Inc.

SECTION 2. The Town Council of the Town of Davie authorizes this expenditure of \$5,250.00 from the Law Enforcement Trust Fund.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
