TITLE OF AGENDA ITEM: A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ACCEPTING THE BIDS FOR AUTOMOBILES AND TRUCKS.

REPORT IN BRIEF: Each year the Town needs to replace vehicles in its fleet which have become high maintenance items due to excessive mileage. There are two major vehicle bids awarded in the State of Florida each year. These bids are awarded by the State of Florida and the Florida Sheriff's Association. Each bid is awarded to the lowest bidder for each geographic section of the State. However, the base vehicles on each contract are configured differently. Therefore, each bid has advantages depending on the base vehicle plus options which the entity is looking to purchase. Staff has compiled a list of vehicles that it anticipates purchasing and requests the latitude to use whichever bid is more economically advantageous for each purchase. Additionally, staff requests the latitude to vary from the attached list provided that the total dollars spent on replacement vehicles does not exceed the established budget.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ACCEPTING THE BIDS FOR AUTOMOBILES AND TRUCKS.

WHEREAS, the Town is in need of replacement vehicles; and

WHEREAS, the State of Florida and the Florida Sheriff's Association solicited bids for such automobiles and trucks; and

WHEREAS, the Town will purchase the needed vehicles from whichever contract is more economically advantageous; and

WHEREAS, staff requests the latitude to vary from the attached list provided that the total dollars spent on replacement vehicles does not exceed the established budgets; and

WHEREAS, vehicles purchased from the Law Enforcement Trust Fund will be in compliance with Florida State Statute 932.704 and will not be a recurring cost; and

WHEREAS, after review, the Town Council wishes to accept the bids awarded by the State of Florida and the Florida Sheriff's Association to the lowest bidder for each geographic section of the State.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council accepts the bids awarded by the State of Florida and the Florida Sheriff's Association to the lowest bidder for each geographic section of the State and approves the purchase of required vehicle in accordance with Attachment "A" which represents the anticipated purchases.

SECTION 2. The Town Council hereby authorizes the expenditure from the Vehicle Maintenance-Capital Outlay Account and the Police Department-Law Enforcement Trust Fund.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
