A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ACCEPTING THE BID FOR POLICE AND FIRE DEPARTMENT UNIFORMS.

**REPORT IN BRIEF:**

The Town requested competitive bids on uniforms for employees of the Police and Fire Departments. The Town received three (3) bids. The recommendation is for Argo Uniform who submitted the lowest bid. Argo Uniform is the Town's current supplier and has provided good customer service and quality garments. The initial contract is a one (1) year agreement with an option to renew for two (2) additional one year terms by mutual agreement of the parties. Extensions, if appropriate, will be handled administratively by staff subject to budgetary approval by the Town Council.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ACCEPTING THE BID FOR POLICE AND FIRE DEPARTMENT UNIFORMS.

WHEREAS, the Town is in need of uniforms for employees of the Police and Fire Departments;  
and

WHEREAS, the Town solicited sealed bids for such uniforms; and

WHEREAS, after review, the Town Council wishes to accept the bid of Argo Uniform.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council hereby accepts the bid of Argo Uniform for Police and Fire Department uniforms in accordance with the prices identified in Attachment "A". Should the contractor default for any reason during the term of this agreement, the Town will award to the next lowest bidder.

SECTION 2. The initial contract term is one (1) year with an option to extend the contract for two (2) additional one year terms by mutual agreement of the parties. Contract extensions, if appropriate, will be handled administratively by staff subject to budgetary approval by Town Council.

SECTION 3. The Town Council hereby authorizes the expenditure from the Police and Fire Department Uniforms Accounts.

SECTION 4. This resolution shall take effect immediately upon its passage and adoption.

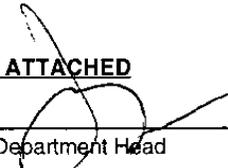

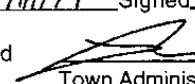

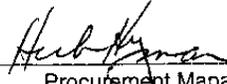
