A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, ACCEPTING THE BID FOR DEMOLITION OF NON-HISTORIC AND UNSOUND BUILDINGS AT THE OLD DAVIE SCHOOL SITE.

WHEREAS, the Town is in need of demolition of various buildings at the Old Davie School Site which have been deemed to be unsound or of non-historic value; and

WHEREAS, the Town solicited sealed bids for such demolition services; and

WHEREAS, after review, the Town Council wishes to accept the bid from International Salvage, Inc.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council hereby accepts the bid from International Salvage, Inc. to demolish these designated buildings at the Old Davie School Site in the amount of \$19,850.00. Should the contractor default for any reason during the term of this agreement, the Town will award to the next lowest bidder.

SECTION 2. The Town Council hereby authorizes the expenditure from the General Fund Contingency Account.

SECTION 3. This Resolution shall take effect immediately upon its passage and adoption.






