A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE EXPENDITURE FOR DAVIE POLICE SPECIAL INVESTIGATIVE FUNDS FROM THE LAW ENFORCEMENT TRUST FUND

WHEREAS, Florida State Statutes 932.704, provides for the use of funds from the Law Enforcement Trust Fund for the purpose of criminal and narcotic investigations; and

WHEREAS, the Davie Police Department has a working and productive Special Investigations Unit to target illicit drug activities; and

WHEREAS, the quality and quantity of cases made against violators is of paramount concern in order to ensure sound convictions and seizures; and

WHEREAS, the Police Department wishes to use \$6,000 needed for these investigative purposes from the Law Enforcement Trust Fund, in compliance with Florida State Statute 932.704, which is not a recurring cost.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council of the Town of Davie hereby approves the expenditure of \$6,000 for investigative services.

SECTION 2. The Town Council authorizes the expenditure from the Law Enforcement Trust Fund.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
