REPORT IN BRIEF: The Florida Motor Vehicle Theft Prevention Authority grant would significantly increase our ability to prevent, combat and reduce motor vehicle thefts in the Town of Davie. The monies from this grant will be utilized for the purchase of "The Club", C.A.T. program essentials, V.I.N. etching equipment, educational pamphlets and programs and two laptop computers, which will be used for the purpose of compiling data relating to the implementation of the anti-theft deterrent program.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE MAYOR, TOWN ADMINISTRATOR AND APPROPRIATE STAFF TO SUBMIT AN APPLICATION FOR GRANT FUNDING AND APPROVE THE EXPENDITURE, IF GRANT IS AWARDED, UNDER THE FLORIDA MOTOR VEHICLE THEFT PREVENTION AUTHORITY PROGRAM ADMINISTERED BY THE FLORIDA OFFICE OF THE ATTORNEY GENERAL

WHEREAS, the Florida Office of the Attorney General administers the Florida Motor Vehicle Theft Prevention Authority Program; and

WHEREAS, grant funding is available under the Florida Motor Vehicle Theft Prevention Authority Program for anti-theft deterrent programs; and

WHEREAS, the monies from this grant will be utilized to start the Combat Auto Theft (C.A.T.) program; to initiate a V.I.N. etching project; and the distribution of "The Club"; and

WHEREAS, to implement these programs the Police Department will need two laptop computers, essential equipment, and printing of various pamphlets and other necessary educational documents for the anti-theft deterrent program.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council of the Town of Davie authorizes the Mayor, Town Administrator and/or appropriate staff to submit an application for grant funding under the Florida Motor Vehicle Theft Prevention Authority Program.

SECTION 2. The Town Council hereby authorizes the Mayor to accept the grant and the expenditure of grant funds, in the amount of \$35,219, when and if the grant is awarded.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
