A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE EXPENDITURE OF FUNDS FROM THE LAW ENFORCEMENT TRUST FUNDS TO SUPPLEMENT THE DAVIE POLICE EXPLORERS POST #564

WHEREAS, the Davie Police Explorers of Post #564 is comprised of young high school aged men and women in the community who are Police oriented; and

WHEREAS, during each year the Davie Police Explorers Program is an active youth program which develops participants as role models and provides a positive environment as an alternative to criminal activity in our youth; and

WHEREAS, supplemental funding is needed throughout the year for the Explorers to represent the Town of Davie in Police Explorer competitions and conferences; and

WHEREAS, the Police Department wishes to supplement an amount not to exceed \$15,000 to the Davie Police Explorer Post #564 from the Law Enforcement Trust Fund, in compliance with Florida State Statute 932.704, which is not a recurring cost.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council of the Town of Davie hereby approves the expenditure not to exceed \$15,000 to the Davie Police Explorer Post #564.

SECTION 2. The Town Council authorizes the expenditure from the Law Enforcement Trust Fund.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
