A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE PARKS AND RECREATION ADVISORY BOARD TO REVIEW AND PROVIDE RECOMMENDATIONS REGARDING THE METHODS, MANNERS AND PRACTICES INVOLVED AND TO BE FOLLOWED BY THE TOWN FOR ITS FUTURE DELIVERY FOR YOUTH AND ADULT RECREATIONAL AND ATHLETIC PROGRAMMING.

WHEREAS, the Town of Davie is committed to providing high quality youth and adult recreational and athletic programming and services; and

WHEREAS, the Town of Davie is dedicated to proactively reviewing the methods, manner and practices involved and followed for its future delivery of said programming and services; and

WHEREAS, the Town of Davie is committed to ensuring that said programming and services will be provided in a safe, secure and nurturing environment; and

WHEREAS, the Parks and Recreation Advisory Board was created by Resolution R-96-283; and

WHEREAS, the Town of Davie Parks and Recreation Advisory Board was established to advise the Town Council as to the needs, desires and concerns of the town's residents with regard to its available resources, recreational opportunities, and athletic programming services; and

WHEREAS, the Town has experienced tremendous population growth over the past decade, and significant enrollment within most, if not all of its athletic programs, together with the concurrent demands placed upon its resources, recreational and athletic programming and services; and

WHEREAS, the Town Council desires to receive recommendations from its advisory board, departmental staff and members of the community as to the manner and methods to be followed for the town's future delivery of said recreational and sports programming and services, so that residents are ensured that they will be provided in a safe, secure and nurturing environment; and

WHEREAS, the Town Council deems it appropriate to delegate the necessary authority to the Town of Davie Parks and Recreation Advisory Board to meet and work with staff, coaches, youth and adult participants, and parents of participants, in order to review the

recreational and athletic programming and services, in a safe, secure and nurturing environment conducive to the smooth operation of sports and recreational activities, programming and services.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie hereby authorizes the Parks and Recreation Advisory Board to investigate and report to the Davie Town Council on the provision of youth sports programs by other agencies and non-profit organizations to include, but not limited to the following topics: policies and procedures to provide youth sports programs including background and reference checks for volunteers and staff, payment of youth sports officials, fees and charges associated with youth sports, responsibilities of parents, youth and volunteers for the provision of youth sports, the use of a commission for youth sports, future staffing and funding for the youth sports programs.

SECTION . This resolution shall take effect immediately upon its passage and adoption.
