WHEREAS, Resolution No. R-2000-113 approved the submission of the grant application and approved funding if awarded; and

WHEREAS, the Police Department now wishes to purchase "The Club" for auto theft education and reduction initiatives in the Town of Davie; and

WHEREAS, Winner International, a sole source provider, will furnish "The Club" at a cost of \$19.95 each, which includes shipping and handling costs; and

WHEREAS, the Police Department wishes to purchase "The Club" from Winner International in the total amount of \$19,950 and will be reimbursed by the Florida Motor Vehicle Theft Prevention Authority Grant #00-015-00.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA:

SECTION 1. The Town Council of the Town of Davie hereby approves the purchase of "The Club" from Winner International, a sole source provider.

SECTION 2. The Town Council authorizes the expenditure of \$19,950 from Capital Outlay, which will be reimbursed by Florida Motor Vehicle Theft Prevention Authority.

SECTION 3. This resolution shall take effect immediately upon its passage and adoption.
