TITLE OF AGENDA ITEM:

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE MAYOR TO EXECUTE CHANGE ORDER #1 WITH INTRASTATE CONSTRUCTION CORP. FOR DIRECTIONAL BORING AND THE INSTALLATION OF PLUMBING PIPING UNDER ORANGE DRIVE FOR TWO DRINKING FOUNTAINS FOR T "LINEAR PARK" PROJECT.

REPORT IN BRIEF:

Two drinking fountains are to be installed in Linear Park. The water main is on the north side of Orange Drive. Directional boring under Orange Drive and the installation of plumbing piping under the street will be required to supply the drinking fountains located in Linear Park on the south side of the street. This expense was not in the original bid since the Architect stated that the water main was on the south side of the street. Therefore, this change order reflects the additional cost of bringing water service from the north side of the street to the south side of the street as required.

A RESOLUTION OF THE TOWN OF DAVIE, FLORIDA, AUTHORIZING THE MAYOR TO EXECUTE CHANGE ORDER #1 WITH INTRASTATE CONSTRUCTION CORP. FOR DIRECTIONAL BORING AND THE INSTALLATION OF PLUMBING PIPING UNDER ORANGE DRIVE FOR TWO DRINKING FOUNTAINS FOR THE "LINEAR PARK" PROJECT.

WHEREAS, the Town of Davie previously awarded the bid to Intrastate Construction Corp. by Resolution R-2001-105; and

WHEREAS, the Town has expanded the Scope of Work to include directional boring and the installation of plumbing piping under Orange Drive for two drinking fountains in Linear Park as Change Order #1 .

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF DAVIE, FLORIDA.

SECTION 1. The Town Council of the Town of Davie does hereby authorizes the appropriate Town officials to execute Change Order #1 with Intrastate Construction Corp. in the amount of \$7,236.08, a copy of which is attached hereto as Exhibit "A".
