Management or promoters reserve the right to remove any exhibitor for any cause felt to be in poor taste or for not complying with the event rules at any time.

NO CARS will be allowed on the Car Show Grounds for setup purposes after 9:45am, nor will any cars be permitted on the Car Show Grounds before closing time, unless specified differently by Event Organizers. Exhibitor must be completely set up no later than 10:00am on the day of the show.
