

**TOWN OF DAVIE  
REGULAR MEETING  
JANUARY 6, 2016**

**I. PLEDGE OF ALLEGIANCE**

The meeting was called to order at 6:30 p.m. and was followed by the Pledge of Allegiance.

**II. ROLL CALL**

Present at the meeting were Mayor Paul, Vice-Mayor Starkey and Councilmembers Caletka, Hattan and Luis. Also present were Town Administrator Lemack, Assistant Town Administrator Lewis, Town Attorney Rayson, Assistant Town Administrator Holste and Town Clerk Roig recording the meeting.

**III. OPEN PUBLIC MEETING**

Arthur Joseph discussed items that could affect the outcome of the next election: the costs of fighting the FLL runway expansion; the cost of the bridges at Southwest 14 Street and SW 130 Avenue and the Orange Drive canal; the mishandling of the Shenandoah fire house; the lack of a "For Sale" sign on the property on Southwest 14 Street and Southwest 130 Avenue.

1. Dr. Martin Luther King Jr. Day (January 18, 2016)  
Councilmember Hattan made a motion, seconded by Vice Mayor Starkey to approve the resolution. In a voice vote, all voted in favor. (Motion carried 5-0)  
Mayor Paul read the proclamation.  
Staff provided information on planned activities for the event, to be held on January 17 at Carter Park from 1 p.m. until 4 p.m.

Vice Mayor Starkey requested tabling the approval pending a correction.

### Purchasing

#### 13. BID SELECTION

Councilmember Caletka stated he would vote against this as he believed there were more suitable vehicles regarding functionality, gas mileage, safety ratings and cost from which the Town should choose. He recommended approving the item, but removing the Interceptor utility and SUV vehicles for the Police Department and allowing the Police Chief to select an E-85 compatible sedan, and allowing the Fire Department to select smaller SUVs that were also E-85 compatible.

Mayor Paul wanted additional time to review Councilmember Caletka's research. Mr. Lemack was concerned that a delay would cause them to miss the cycle of purchases. Herb Hyman, Procurement Manager, explained that they could miss the production line and orders needed to be submitted before April 1. Continuing to use vehicles designated for replacement would cause them to continue to accrue mileage. They must also wait to auction off the old vehicles until the new vehicles were received. He agreed that just two weeks would not have extremely adverse effects.

Councilmember Luis discussed the advantages of the larger SUVs and said every officer he spoke to loved them. Police Chief Patrick Lynn said they had done their own research and there were pros and cons with every vehicle. He believed the Interceptor would replace the Crown Victoria as the Police vehicle of choice.
