APRIL 20, 2016**

RESIDENT REQUEST. Mayor Paul said a resident in an R-5 zoned area wanted to know if Council would consider revising the ordinance to allow certain livestock in zoning areas other than R-1. She specifically wanted to keep a goat. Aside from Councilmember Caletka, Council agreed to send the idea to the Agriculture Advisory Committee to consider.

HOLOCAUST MEMORIAL BILL. Mayor Paul had been present when Governor Scott signed the bill for the holocaust memorial planned in Tallahassee. Governor Scott had presented a Governor’s Medal of Freedom to one of the holocaust survivors in attendance.

WOMEN’S CLUB HISTORIC REGISTER APPLICATION. Mayor Paul reported the application had made it through the State and was on its way to Washington. She was compiling letters of support to accompany the application

ORANGE BLOSSOM CRIME WATCH MEETING. Mayor Paul stated the meeting was the following evening.

ORANGE PARK COMMUNITY MEETING. Mayor Paul reminded everyone that the meeting would be the following week.

SENIOR VANS. Mayor Paul said they only had one senior van now, and wanted to know if David Flaherty, Parks and Recreation Director, would put a second van back in the budget. Mr. Flaherty reported there was still a second van but it had been in the garage for repairs for a while. He agreed to provide Mayor Paul with an update. Councilmember Hattan asked if there was money in the CRA to purchase a larger senior citizens’ van. Mr. Moss stated they were seeking CDBG funds for the new bus.

THIRD ANNUAL CHARITY ANIMAL FASHION SHOW AND OPEN HORSE SHOW. Mayor Paul announced the show would raise funds for the Friends of the Davie Farm Park and Project Stable on June 12. Registration started at 9 a.m., the fashion show was at 10 a.m. and the horse show was at noon.

XIII. TOWN ADMINISTRATOR’S COMMENTS

DISTRICT 1 COMMUNITY FORUM. Mr. Lemack announced the meeting would be held in Council Chambers on May 11 at 6 pm.

RESOURCE RECOVERY BOARD SETTLEMENT. Mr. Lemack said this was very important and credited Mr. Rayson for spearheading the issue.

XIV. TOWN ATTORNEY’S COMMENTS

RESOURCE RECOVERY BOARD SETTLEMENT. Mr. Rayson reminded everyone that the County had taken all of the funds from the RRB after the board was dissolved, despite the fact that the agreement called for the funds to be distributed among the municipalities. Litigation had resulted in a settlement including 18 municipalities, which had been awarded \$32 million, to be distributed based on tonnage. The municipalities had also been granted the Alpha-250 property, 22+

acres under the jurisdiction of Pompano Beach, which had unique solid waste zoning. The assessed value of Alpha-250 was \$6.5 million and the market value was approximately \$8 million. Mr. Rayson had suggested keeping the Alpha-250 property and studying what the highest and best use would be. Before the meeting the previous week, County Commissioner Beam Furr had proposed delaying the sale by a year or two and the County would invest in a comprehensive study regarding instituting a solid waste authority. The vote in favor of this had been unanimous. Mr. Rayson agreed to keep Council apprised of the progress on this issue. Councilmember Starkey thanked Mr. Rayson for his efforts.

XV. ADJOURNMENT

There being no further business to discuss and no objections, the meeting was adjourned at 7:19 pm.
