**4.1 Variance (V) 15-315 Gillman**

*11081 Southwest 30th Court*

Attorney Weinthal confirmed that the applicant waived the quasi-judicial process. There was no one in the public wishing to speak on this item.

Mr. Stallworth then gave a summary of the staff report, advising this matter would be going before Town Council on January 6th.

Mr. Jerry Gillman, the applicant, addressed the Board.

Discussion ensued regarding property lines and right-of-way, location of and materials constructing the driveway, swale and easements, drainage, engineering permitting, building occupancy, location of existing tree affecting setback, and letters from adjoining neighbors.

Chair DeArmas then opened and closed the public hearing as there was no one wishing to speak on this item.

All of the Board members expressed concern regarding the side setback, suggesting alternatives to reduce the setback to 20 feet, which would be more acceptable.

**Motion** made by Mr. Cory, seconded by Vice Chair Jacob, to **deny** Variance 15-315.

In a roll call vote, the motion passed 3-0 (with Mr. Bender and Ms. Davidson absent).
