The Florida Department of Transportation (FDOT), District Four, will conduct a public meeting regarding the proposed improvements along SR 93/ I-75 from Sheridan Street to Griffin Road, in Broward County. This Public meeting will be offered in two different formats: virtual and in-person. The public meeting will have representatives available to answer questions. Project information will be available for public viewing. Questions and comments may be submitted prior to the meeting by emailing the Project Manager. ### PROPOSED IMPROVEMENTS

- Roadway widening to provide continuous auxiliary lanes in each direction of traffic
- Repaving and restriping the existing asphalt
- Constructing a new outside shoulder
- Replacement of signage impacted by construction
- New pavement markings
- Replacement of lighting, Intelligent Transportation Systems (ITS), and drainage impacted by the roadway widening

### CONSTRUCTION IMPACTS

- Work will be done in phases to reduce the inconvenience to the community
- Lane closures, ramp closures, and detours will occur during non-peak hours to minimize impacts on traffic
- Access to businesses and residential properties will be maintained at all times during construction
- Night-time work is expected for pavement resurfacing, widening and construction activities outside of the travel lanes
