BUILDING PERMIT FEE SCHEDULE

(1) **IN GENERAL**

a. All fees will be rounded to the nearest whole dollar amount.
b. Standard for calculating construction value will be determined by the Building Division using the greater of a nationally recognized cost analysis program or by a copy of the signed contract between the owner and the contractor.

(2) **APPLICATION SURCHARGES**

a. Broward County Board of Rules and Appeals Surcharge per Broward County Resolution 2012-487	\$0.68 per \$1,000 of construction value (\$2.00 min)
b. Training and Education Surcharge: fee to be used only to train Building Division personnel.	\$0.25 per \$1,000 of construction value (\$2.00 min)
c. Technology Fee: all fees collected pursuant hereto shall be set aside to offset the cost of computer system purchases or technology expenditures within the Building Division.	6% of the permit fee
d. Fire Prevention Training and Education Surcharge: for all permits that require Fire Department review and/or inspection. The surcharge shall be paid to the Fire Departments Fire Prevention Bureau Training Fund. This fee shall only be used to provide training to Fire Prevention Personnel.	\$0.25 per \$1,000 of construction value
e. Fire Prevention Technology Fee: for all permits that require Fire Department review and/or inspection. All fees collected pursuant hereto shall be set aside to offset the cost of computer system purchases or technology expenditures within the Fire Prevention Bureau.	6% of the permit fee
f. Department of Business and Professional Regulation Building Permit Surcharge per Florida Statute 553.721	1% of the permit fee (\$2.00 min)
g. Building Code Administrators and Inspectors Board Building Permit Surcharge per Florida Statute 468.631	1.5% of the permit fee (\$2.00 min)

(4) **PLAN REVIEW FEES***

a. Minimum Fee	\$25.00
b. Single Family Residential, Duplex, Townhouse and appurtenances of	0.75% of construction value
c. Construction other than above	0.75% of construction value
* This fee is non-refundable once plan review has commenced. Up to 50% of the application fee may be refunded at the discretion of the Building Official if the project is denied by any outside agency or by extenuating circumstances not under the direct control of the contractor, developer or property owner.	
d. Pre/Early plan review (plan review prior to site plan or council approval) cost per required discipline	\$250.00
e. Lost Plans Review	\$10.00/page
f. Correction Resubmission: not credited towards permit fee; paid at time of third submittal and all subsequent submittals when previous comments have not been addressed	\$50.00 per Discipline or \$15.00 a sheet whichever is greater
g. Truss Plan, Shop Drawings, or Product Approval Review for Plans Submitted after permit issued: (price per item)	\$50.00
h. Minor changes after permit is issued (less than 1 hour of review time per discipline) - If proposed changes add value the permit fee will be re-calculated using the new value and the additional fee will be added to the revision fee.	\$75.00/hour
i. Major changes after permit is issued- If the proposed change represents a major alteration of floor plan and/or the configuration of the structure involving extensive reexamination computation, the original permit shall be voided	New permit fee + 1/2 of original fee may be applied to new permit
j. Specialty overtime/after hours Plan Review (Per Discipline)	\$450.00

The permit fee shall be applied to each building permit separately.

Construction value between \$30,000,000.01 to \$45,000,000.00	0.5% of construction value + \$300,000.00
Construction value over \$45,000,000	0.25% of construction value + \$375,000.00
c. Permit Card Replacement	\$28.00
d. Permit refunds for cancelled permits	50% of permit fee
e. Renewal of expired permit within 90 days of expiration	50% of original fee
f. Renewal of expired permit after 90 days of expiration	100% of original fee
* Refund request shall be submitted in writing by permit applicant. No refunds for: 1. Plan Review if review work commenced or completed 2. Permit, if any inspections scheduled or logged 3. Permits on jobs that expired prior to request 4. Fees collected for State or County.
