- Criminal Law

The plan pays 100% of the attorneys' fees, in most cases. The plan covers the employee, spouse and dependent children to age 23, if enrolled in an accredited university/college full-time. Plan benefits include consultations with the attorney, 24/7 emergency services, online will preparation and legal library, and much more.
